## Which Health Plan Is Best For Me And My Family? Check Out The myBenefitsMentor® Consumer Decision Tool

The myBenefitsMentor® Consumer Decision Online Tool is available to active State of Delaware employees hired before March 1, 2017 and is designed to help them make the best selection from the four health plans offered during Open Enrollment (May 14 - 26): Highmark Delaware First State Basic PPO Plan; Aetna CDH Gold Plan; Aetna HMO Plan; and Highmark Delaware Comprehensive PPO Plan. As a result, employees can more accurately select the best health plan for them and their family that reflects their personal medical needs and budget.

*What can I do with the myBenefitsMentor® Consumer Decision Online Tool?*

- ⇒ View your prior healthcare usage and out-of-pocket costs (if available) for health and prescription services, along with your estimated premiums and out-of-pocket costs for the upcoming plan year that begins July 1
- ⇒ Make adjustments based on anticipated health care needs in the plan year ahead
- ⇒ Compare benefit design and estimated total costs by health plan
- ⇒ Access helpful tips and resources
- ⇒ Receive a recommendation on the most cost effective plan
- ⇒ View and print a customized enrollment guide

Within the next week, employees will receive a personalized and confidential letter at their home that will contain a summary of the healthcare information and resources available in the online tool.
