### New Plan Year

Making informed decisions regarding your well-being starts with understanding your healthcare options. As an engaged consumer, it's important to know where to seek care for you and your family. At the Statewide Benefits Office (SBO), our goal is to provide you with the resources and education needed to access high-quality health care that produces good outcomes at an affordable cost, promotes healthy lifestyles, and gives you peace of mind. # State Employee Benefits Committee (SEBC) Corner

In June 2025, the SEBC held two meetings. During the June 13 meeting, the SEBC continued its review and discussion of the Pharmacy Benefit Manager (PBM) Request for Proposal (RFP). At the June 27 meeting, the Committee reviewed and approved the final drafts of the PBM and vision benefits RFPs. The SEBC also discussed the draft Health Data Warehouse RFP and Group Health Insurance Plan (GHIP) financials.

# **Compare Providers and Facilities**

## **Benefit Paycheck Deductions**

The first Flexible Spending Account (FSA) deductions for the new plan year for State employees will be deducted from paychecks on July 11, 2025. The first health, dental, vision, Group Universal Life (GUL) Insurance, and Accident & Critical Illness Insurance benefit deductions for the new plan year for State employees will be deducted from paychecks on July 25, 2025. Remember, State non-Medicare health plan premiums (rates) increased on July 1, 2025.

### State Group Universal Life Insurance

Benefits elected during the 2025 Open Enrollment period will begin July 1, 2025. If you missed enrolling in life insurance during Open Enrollment, all is not lost.

The State has partnered with Securian Financial to provide Group Universal Life (GUL) Insurance benefits, a type of permanent life insurance with the option for tax-deferred cash accumulation. This coverage will help protect your family against the unexpected loss of your life and income.

You can select or increase your coverage anytime throughout the year. Employee coverage is available at 1-6 times your base annual salary, up to \$350,000. Be aware that mid-year enrollment or coverage changes outside of a qualifying event will require proof of good health.
