Centers of Excellence (COEs) improve health outcomes and lower cost



COEs (medical facilities <u>and</u> professionals) provide employers and members with <u>better health</u> <u>outcomes</u> at a <u>lower cost</u> than in community/health plan networks



Savings are achieved via **discounted or bundled pricing** and **improved quality** (e.g., fewer preventable readmissions, adverse events, and deaths)



One well-recognized COE had **mortality rates** for cardiac bypass that were **3 – 5 times better** than the statewide hospital averages and those deaths are only the tip of the iceberg in poor care

Then

Originally used for high-cost, specialized transplants (heart/lung/liver)

Now

Broadly available today and used for a variety of care including heart and bariatric surgery, joint replacement, and expanding to include infertility, general surgery, designated ambulatory centers and non-surgical cancer treatment. Carriers are now moving towards pairing a panel of designated surgeons with their COE facilities.

GHIP COE experience

- COEs are available through provider networks maintained by Highmark and Aetna, as well as through the GHIP's third-party COE vendor, Employer Direct Healthcare, which administers the SurgeryPlus program
 - Members can choose between their medical carrier COEs or SurgeryPlus COEs
 - Beginning July 1, 2023, bariatric surgeries are only available as a covered benefit under the SurgeryPlus COE network
- The chart below reflects the total number of procedures completed each year for GHIP members through the SurgeryPlus program
 - Member utilization of SurgeryPlus as an option has progressively increased year-over-year

Background on the 2023 COE RFP

- SEBC first implemented the SurgeryPlus program through Employer Direct Healthcare, a third-party administrator of COE services, effective July 1, 2019 (FY20), based on the SEBC's desire to:
 - maintain consistency in the GHIP non-Medicare member experience across all medical plans wherever possible; and
 - promote competition among the providers in Delaware to achieve the best possible pricing on medical services for non-Medicare plan participants as well as the GHIP
- These services are offered as a choice alongside Highmark and Aetna medical networks, with the exception of bariatric surgery which is only available through a SurgeryPlus COE provider (new as of July 1, 2023)
- SEBC's contract with Employer Direct Healthcare expires on June 30, 2024
- Current RFP is the second time that the SEBC has marketed this benefit (initially in 2018)

COE RFP objectives


Identify third-party administrators of COE services that can deliver services that include, but are not limited to, the following:

- Reduce total cost of care for the GHIP and plan participants, without sacrificing quality of care delivered
- Facilitate choice of medical providers who deliver high quality care at a lower total cost of care
- Support financial rewards to medical providers who deliver high quality care at a lower total cost
- Build and maintain a stable COE provider network* based on quality and cost efficiency across a variety of clinical procedures (e.g., orthopedic, spine, bariatric, cardiac)
- Frequently *monitor the quality* of providers within the COE network, using publicly available sources of quality and cost efficiency data
- Provide a *consistent user experience* for GHIP members regardless of medical plan selection
- Collaborate with other GHIP vendor partners (Aetna, Highmark, CVS) to deliver services to plan participants
- Articulate **experience** with various COE benefit designs, network offerings, claims adjudication, member incentives, care coordination, member education and other aspects of COE benefits administration
- **Provide excellent customer service** to GHIP participants, including concierge support for accessing COE services, and to the State as the plan sponsor
- Provide competitive financial terms and performance guarantees

*Note: COE provider network defined in the RFP as both medical facilities and medical professionals.
