CALLED TO ORDER - LIEUTENANT GOVERNOR BETHANY HALL-LONG

Lieutenant Governor Hall-Long called the meeting to order at 4:00 P.M.

PUBLIC COMMENT

Members from the public provided comment on Medicare Advantage (MA) as it compares to the Medicfill plan, having prior authorizations, a network and coinsurance. A member from the public provided comment on keeping the current Medicfill plan with plan design changes, pricing out a Health Reimbursement Account (HRA) for use in the individual marketplace, and commented on the follow-up document regarding mention of the 90th percentile costs on GHIP Medicfill and individual marketplace plans. A few members from the public addressed concerns with an HRA and the individual marketplace. A member of the public commented that they do not like the current Zoom webinar function to host these meetings and would prefer to use the Zoom meeting function. Members of public stated that they were promised quality retiree benefits for their service to the state and a 1% OPEB funding option is not reasonable enough to address to the OPEB liability. Additional comments from the public include difficulties understanding the employee benefits survey, recommended options to address the OPEB liability, the State's failure to budget properly on funding retiree benefits, requests for quality data and updates to the FY22 Q4 Financial Report to reflect reconciliations.

Director Cade arrived to the meeting.

APPROVAL OF MINUTES - LIEUTENANT GOVERNOR BETHANY HALL-LONG

A MOTION was made by Mr. Emsley and seconded by Representative Baumbach to approve the minutes from the Retiree Healthcare Benefits Advisory Subcommittee meeting on April 3, 2023. MOTION ADOPTED UNANIMOUSLY.

OTHER POST-EMPLOYEMENT BENEFITS (OPEB) OPTIONS - MR. CHRIS GIOVANNELLO, WTW

Mr. Giovannello reviewed the OPEB liability and future liability estimates assuming no changes in plan design, eligibility, or funding. Options to reduce the OPEB liability were presented and grouped into three categories: increased funding, eligibility changes, and plan design. Combining options from each category will provide the greatest impact to reduce the OPEB liability. Mr. Giovannello displayed options to reduce the OPEB liability that were modeled by the Retirement Benefit Study Committee (RBSC) from each category and provided additional options for potential consideration that have not been previously modeled.

Ms. Tempkin from Cheiron provided insight into the OPEB liability from an actuarial point of view and noted that adding additional dollars to OPEB has a greater impact on future liability than health care cost saving because of the discount rate variation that is applied to each action.

Senator Pettyjohn left the meeting. Ms. Allen left the meeting.

MAY 1ST STATUS REPORT – LIEUTENANT GOVERNOR BETHANY HALL-LONG

Lieutenant Governor Hall-Long discussed the May 1st Status report to the General Assembly and displayed the outline for this report. This report will include a summary of Subcommittee activity, SEBC decision on Medicare health plan for FY24, areas of focus requiring further consideration, and expected meeting timeframe for post FY24 recommendations.

Secretary DeMatteis left the meeting.

DISCUSSION BY SUBCOMMITTEE MEMBERS

Subcommittee members continued discussion on the OPEB liability options, the May 1st status report, and future dates for additional Subcommittee meetings.

PUBLIC COMMENT

Members of the public provided comment on the OPEB options, additional non-modeled OPEB options, and HB 75 containing language on Medicare Advantage. A member of the public provided a recommendation to codify the OPEB funding, payroll contributions, and a percent of surplus resources and to rate each group individually rather than together.

ADJOURNMENT

A MOTION was made by Mr. Emsley and seconded by Representative Baumbach to adjourn the public session at 5:55 P.M. MOTION ADOPTED UNANIMOUSLY.
