### State of Delaware Group Health Insurance

FY 2019, 4th Quarter Net Payments, Utilization and Trends from Incurred Claims



#### Notable Trends

Based on incurred claims during FY19 (July 1, 2018 – June 30, 2019) compared to incurred claims during FY18 (July 1, 2017 – June 30, 2018)<sup>1</sup>:

- On a per member per month (PMPM) basis, net medical and drug payments increased from \$537 to \$564 (5.2%).
- Total net payments for medical and drug claims increased by 6.9% to \$739.5 million. The increase was driven by a \$21.1 million (9.7%) increase in drug payments that included a \$8.4 million (25.4%) increase in drug payments among high cost claimants (HCCs).
- The \$26.3 million increase in medical payments was driven largely by outpatient facility claims (an increase of \$9.2 million and a 4.6% trend), professional services claims (an increase of \$6.8 million an 8.0% trend), and radiology outpatient claims (an increase of \$3.8 million and a 10.2% trend).
- The increase in costs for professional services was in part driven by an increase in professional specialty drugs (14.3% PEPM trend) and the increase in costs for physician outpatient services was in part driven by a 9% PEPM trend in non-specialty office visits.
- Although payments for inpatient claims increased by \$1.3 million, on a PEPM basis the trend was slightly negative (-0.6%). A 7.6% PEPM trend in inpatient maternity services was mitigated by a -5.65% PEPM trend for non-surgical inpatient services.
- In terms of clinical conditions impacting trend, the PMPM payments for chemotherapy encounters increased by 29.4% from \$9.83 to \$12.72. Claims for pregnancy related services (PMPM trend of 7.9%), newborns (PMPM trend of 14.9%), spinal and back disorders (PMPM trend of 5.7%), coronary artery disease (PMPM trend of 13.4%), respiratory disorders (PMPM trend of 11.0%), and diabetes (PMPM trend of 18.4%) were also notable clinical conditions contributing to increased costs.
- There were notable increases in the utilization of outpatient mammograms and outpatient therapeutic radiology services contributing to an overall increase in utilization of radiology services and increases in the PEPM trends for ultrasounds, mammograms and x-rays contributing to an overall increase of 10.2% in the PEPM trend for outpatient radiology services.



Glossary

Visits per 1000 – the average number of outpatient facility visits under medical coverage, per 1000 members with medical coverage per year.
