Ms. Jaclyn Iglesias continued to review Aetna's GCIT network which provides a narrow network of high-quality providers to access selected cell and gene therapy (CGT) at a lower total cost.

Ms. Jaclyn Iglesias displayed trend data on obesity and weight management, weight management resources, and current GHIP resources to support weight loss.
