CALLED TO ORDER – DIRECTOR FAITH RENTZ, SBO

Director Faith Rentz called the meeting to order at 10:00 a.m.

APPROVAL OF MINUTES - DIRECTOR FAITH RENTZ, SBO

A MOTION was made by Laura Rowe and seconded by Robert Scoglietti to approve the minutes from the combined Financial/Health Policy & Planning Subcommittee meeting on May 15, 2023. MOTION ADOPTED UNANIMOUSLY.

DIRECTOR'S REPORT – DIRECTOR FAITH RENTZ, SBO

Director Rentz reviewed several House and Senate bills that are being monitored by SBO and discussed the status of each bill and any potential fiscal impact.

Director Rentz provided Subcommittee members with agenda items for this afternoon's SEBC meeting and reviewed items discussed at the Retiree Healthcare Benefits Advisory Subcommittee meeting.

PRIMARY CARE DASHBOARD - DEPUTY DIRECTOR LEIGHANN HINKLE, SBO

Deputy Director Leighann Hinkle reviewed the primary care dashboard reporting FY23 Q3 which included an overview of Aetna and Highmark's primary care provider network and Group Health Insurance Plan (GHIP) member utilization.

David Bentz left the meeting.

APRIL 2023 FUND REPORT - CHRIS GIOVANNELLO, WTW

Chris Giovannello detailed the April 2023 fund report to include premium contributions, other revenues, claims, and the updated fund equity balance. The premium contributions are currently \$8.4M below budget for the year due to timing of revenue that is inconsistent with the FY23 GHIP budge.t WTW has readjusted the long-term projections to account for this. Claims were slightly below budget for April; however, claims continue to run high with year-to-date (YTD) claims 4.3% over budget. Fund equity balance is \$78.6M with a variance of \$42.1M.

GHIP KEY TRENDS REPORT - CHRIS GIOVANNELLO, WTW

Chris Giovannello reviewed the key trends report for active employees and non-Medicare retirees on paid claims through April 2023. The executive summary showed increased utilization and unit cost for inpatient medical, outpatient medical, and pharmacy payments with overall trend increasing by 10.2%.

SEBC QUICK REFERENCE DASHBOARD - CHRIS GIOVANNELLO, WTW

Chris Giovannello presented the quick reference dashboard which pulled data from the key trends report to analyze trends in cost and utilization of healthcare. The dashboard displays trends on active employees and early retirees based on utilization and unit cost from the most recent 12 months through April 2023 compared to the previous 12 months through April 2022.

GHIP TREND DEVELOPMENT DISCUSSION - CHRIS GIOVANNELLO, WTW

Chris Giovannello outlined the GHIP trend development which reviewed historical gross claims, forces impacting medical inflation, trend projections and ranges, and next steps for the SEBC.
