# **DIRECTOR'S REPORT – DIRECTOR FAITH RENTZ, SBO**

Director Rentz provided Subcommittee members with agenda items from today's Financial Subcommittee Meeting and for the upcoming SEBC meeting on August 21, 2023. The Financial and Health Policy & Planning Subcommittee meetings will be held separately over the next few months to accommodate more in-depth discussions on agenda topics.

Subcommittee members from the Retiree Healthcare Benefits Advisory Subcommittee provided a recommendation to grandfather retirees through December 31, 2024 and to continue offering a Medigap supplement plan with no changes to what is currently being offered and with the same cost sharing.

The Statewide Benefits Office will be relocating on Tuesday, August 22, 2023 to the Silver Lake Campus. Committee and Subcommittee physical meeting locations will vary for future meetings and a virtual meeting option will still be available.

#### PRIMARY CARE DASHBOARD REPORTING FY23 Q4 – DEPUTY DIRECTOR LEIGHANN HINKLE, SBO

Deputy Director Leighann Hinkle summarized the FY23 Q4 primary care provider (PCP) report analysis on Group Health Insurance Plan (GHIP) member visits to their PCPs.

# GHIP ELIGIBILITY AND ENROLLMENT RULE REVISIONS EFFECTIVE JANUARY 1, 2024 – NINA FIGUEROA, HEALTH POLICY ADVISOR, SBO

Nina Figueroa provided an overview of the GHIP Eligibility and Enrollment Rules review process, highlights for the proposed revisions, a timeline to complete the proposed revisions. Subcommittee members will be asked to review all recommended revisions and provide their input for each recommended revision.

#### WEIGHT MANAGEMENT STRATEGIES – JACLYN IGLESIAS, WTW

Jaclyn Iglesias recapped the SEBC's decision to add weight loss medications with utilization management to the prescription drug plan and discussions previously held by the Health Policy & Planning Subcommittee on weight management strategies. The SEBC received updates in July on the weight management program.

Jaclyn Iglesias provided a utilization update, discussed medical plan coverage of weight management care, and noted considerations for FY25.

# DIVERSITY, EQUITY AND INCLUSION REVIEW - RACHAEL MCCANN JONES, WTW

Rachael McCann Jones conducted a review of the Diversity, Equity and Inclusion (DEI) benefits which included a history of DEI in Human Resources (HR) and total rewards, a need for DEI in the workplace, modernizing benefits, a framework for reviewing benefits through a DEI lens, and an inclusive benefits review.
