CALLED TO ORDER – DIRECTOR FAITH RENTZ, SBO

Director Rentz called the meeting to order at 10:00 a.m.

DIRECTOR'S REPORT - DIRECTOR FAITH RENTZ, SBO

Director Rentz provided Subcommittee members with agenda items for today's Health Policy & Planning Subcommittee and SEBC meetings.

Medicare Open Enrollment for State of Delaware pensioners will begin on October 16, 2023 through October 27, 2023 with the plan year starting on January 1, 2024. The SEBC will be voting on the extension of the Special Medicfill plan for the second half of CY2024. This will be the third extension of the Special Medicfill contract.

APPROVAL OF MINUTES – DIRECTOR FAITH RENTZ, SBO

A MOTION was made by Laura Rowe and seconded Robert Scoglietti to approve the minutes from the Financial Subcommittee meeting on August 14, 2023.

FINANCIALS – BRIAN STITZEL, WTW

Revised June 2023 Fund Report

Brian Stitzel reviewed the revised June Fund Report to update the actual year-to-date claim liability and minimum reserves.

July 2023 Fund Report

Brian Stitzel detailed the July Fund Report and reviewed a new exhibit that includes an executive summary and more detail information on premium contributions, other revenues, claims, and expenses.

Premium contributions (\$78.3M) and other revenues (2.5M) were slightly over budget with claims (\$88M) and expenses (\$4M) under budget. Total costs for the month were \$2.8M less than budget at a deficit of \$11.3M and reduced the FY25 rate action by 0.3%.

GROUP HEALTH INSURANCE PLAN KEY TRENDS REPORT – JACLYN IGLESIAS AND BRIAN STITZEL, WTW

Jaclyn Iglesias discussed some follow-up information on weight loss medication data, key drivers for outpatient costs, and chronic conditions.

Brian Stitzel reviewed the key trends report for active employees and early retirees on paid claims through July 2023. The executive summary continues to show increases in inpatient medical, outpatient medical, and pharmacy payments with overall trend increasing by 11.4%.

SEBC DASHBOARD - BRIAN STITZEL, WTW

Brian Stitzel presented the SEBC dashboard which pulled data from the key trends report to analyze trends in cost and utilization of healthcare. The dashboard displays trends on active employees and early retirees based on utilization and unit cost from the most recent 12 months through July 2023 compared to the previous 12 months through July 2022.
