CALLED TO ORDER – DIRECTOR FAITH RENTZ, SBO

Director Rentz called the meeting to order at 1:00 p.m.

APPROVAL OF MINUTES - DIRECTOR FAITH RENTZ, SBO

A MOTION was made by Courtney Stewart and seconded by Robert Scoglietti to approve the minutes from the Health Policy & Planning Subcommittee meeting on September 18, 2023.

DIRECTOR'S REPORT – DIRECTOR FAITH RENTZ, SBO

The Financial Subcommittee meeting for October was canceled due to lack of agenda items and will reconvene in November.

Director Rentz provided Subcommittee members with upcoming meeting dates, agenda items, and SEBC voting items for upcoming Committee and Subcommittee meetings.

The Medicare RFP will be advertised on October 24, 2023 with minor changes that were made to the statement of work to accommodate recommendations from the Retiree Healthcare Benefits Advisory Subcommittee.

GHIP ELIGIBILITY AND ENROLLMENT RULE CHANGES EFFECTIVE JANUARY 1, 2024 – NINA FIGUEROA, HEALTH POLICY ADVISOR, SBO

Nina Figueroa reviewed feedback that was submitted by Subcommittee members on the proposed revisions to the Eligibility & Enrollment (E&E) Rules and provided additional comments from SBO, DOJ, Office of Pensions, and WTW on the necessity and purpose of these revisions.

The SEBC will be provided the proposed revisions at their next meeting to start discussions on the changes to the E&E Rules and will be asked to vote on these changes at the November SEBC meeting. All revisions need to be submitted to the Registrar of Regulations by December 15, 2023 to be effective January 1, 2024.

Matt Clark raised several issues and concerns regarding the proposed rule changes, specifically seeking clarification around coverage effective dates for new hires.

WEIGHT MANAGEMENT STRATEGIES - JACLYN IGLESIAS, WTW

Jaclyn Iglesias recapped the discussion topics and feedback from last month's Subcommittee meeting and provided follow-up information on weight management strategies. Jaclyn Iglesias conducted a brief overview of how some other states manage their weight loss drugs and noted that these states mandate enrollment in some type of wellness program.

Subcommittee members had a discussion to potentially include a requirement for members to participate in a care management program to help support weight loss efforts.

Jaclyn Iglesias provided a utilization update, discussed medical plan coverage of weight management care, and noted considerations for FY25 and FY26. It was noted that utilization for the first three months of the plan year is nearly the entirety of the FY24 estimate provided by CVS Caremark.

Subcommittee members discussed eliminating the co-morbid conditions requirement in place currently under the GHIP health plans and which prevents members access to covered weight loss consultations, however, Subcommittee members were divided. It was mentioned that the State is very early in offering weight loss medications and more time to gather data should occur before further expanding or changing coverage related to weight loss consultations, treatment, and medications.
