# STATE OF DELAWARE STATEWIDE BENEFITS OFFICE

## **CALLED TO ORDER – DIRECTOR FAITH RENTZ, SBO**

Director Rentz called the meeting to order at 1:00 p.m.

## APPROVAL OF MINUTES – DIRECTOR FAITH RENTZ, SBO

A MOTION was made by Stuart Snyder and seconded by Ashley Tucker to approve the minutes from the Health Policy & Planning Subcommittee meeting on December 11, 2023. MOTION ADOPTED UNANIMOUSLY.

### DIRECTOR'S REPORT – DIRECTOR FAITH RENTZ, SBO

Director Rentz confirmed that the updated Group Health Insurance Plan (GHIP) Eligibility and Enrollment Rules were submitted and accepted by the Registrar of Regulations. Changes largely surround the elimination of the 90-day State Share waiting period pursuant to HB185. SBO has sent communications of these revisions to GHIP organizations, and an updated copy has been posted to the SEBC website.

The Health Policy and Planning Subcommittee will begin work on changes to the Disability Insurance Program (DIP) Rules and Regulations with an effective date of July 1, 2024.

The SBO is currently monitoring several bills that have been filed that would impact the GHIP. Little movement on these bills is expected over the next few weeks as the Legislature will be breaking for the Joint Finance Committee budget hearings.

Director Rentz highlighted agenda items from the Financial Subcommittee meeting and the SEBC and Executive Session meetings. Any health plan benefit changes for FY25 will be voted on by the Committee no later than the end of March to prepare for Open Enrollment (OE). The Committee has two meetings scheduled for the month of March on March 11, 2024 and March 25, 2024

# DISABILITY INSURANCE PROGRAM (DIP) RULES AND REGULATIONS REVIEW – AARON SCHRADER, SBO

Aaron Schrader provided an overview of the DIP Rules and Regulations review process, highlights for the proposed revisions and a timeline to complete the proposed revisions. Subcommittee members will be asked to review all recommended revisions and provide their input for each proposed revision.

# SITE OF CARE STEERAGE – ADDITIONAL CENTERS OF EXCELLENCE OPPORTUNITIES – JACLYN IGLESAIS, WTW

Jaclyn Iglesias reviewed additional centers of excellence opportunities by Employer Direct Healthcare (EDHC) which currently administers the SurgeryPlus program. Bariatric surgery is currently carved out through SurgeryPlus. EDHC would like the Committee to consider carving out additional procedures through SurgeryPlus, such as elective spine and joint procedures. Cost saving estimates are expected in March 2024.

Subcommittee members showed interest in further analyzing opportunities with EDHC, however, did voice some concerns about the provider network and potential ACA implications.

David Bentz arrived to the meeting.

#### DIVERSITY, EQUITY AND INCLUSION REVIEW – JACLYN IGLESIAS, WTW

Jaclyn Iglesias conducted a recap of the Diversity, Equity and Inclusion (DEI) benefits review for short-term and long-term benefit enhancement opportunities. As some of these opportunities have a significant financial impact and the GHIP fund is not financially stable, today's discussion provides an update to outstanding questions from the December meeting related to broad wellbeing, family forming benefits, mental health/emotional wellbeing, and dental benefits.

A Subcommittee member showed strong support for the additional coverage of wigs, cooling caps and mastectomy bras and expressed concerns over the potential cost of other, more expensive benefit changes from the DEI review.
