SurgeryPlus participating providers for total joint and spine procedures

- The tables below provide the total number of SurgeryPlus participating providers located in the metropolitan areas specified for total joint procedures and spine procedures
- Based on these totals, the number of providers would represent a small number of the total number of contracted providers within the Highmark and Aetna medical networks
- WTW is conducting additional analysis to determine the proportion of existing GHIP member utilization of
 joint and spine procedures comprised by these providers and will report back to the Subcommittee once
 those results are available in the spring
