### Site of service

Visits to Emergency Rooms, Urgent Care Centers and Primary Care Providers for Non-Emergent and Primary Care Treatable Conditions

- Total visits increased at all sites of care from 2021 to 2023
- For non-emergent and primary care treatable conditions, visits increased by 6.5% from 2022 to 2023
  - Visits to emergency rooms and urgent care both increased by 10.9%, while visits to primary care physicians only increased 4.4%
  - Average paid per visit from 2022 to 2023 increased 7.7% overall, with the greatest average paid per visit increasing at the emergency room by 7.3%

# Emergency room

Visits to Emergency Rooms and Urgent Care for Top 5 Primary Care Treatable Conditions

- Top 5 non-emergent diagnoses in ER compared to their costs in urgent care in 2023
  - The top 5 non-emergent diagnoses in the ER totaled \$8.2M; had all visits been treated at an
    urgent care center cost would be reduced to \$635k

### Telemedicine

- Utilization for mental health and substance use increased by nearly 45% for Aetna members and decreased by about 5% for Highmark members
- General telemedicine visits through Teladoc (Aetna) remained stable from 2022 to 2023, while AmWell (Highmark) visits increased 50.4%
- Paid per visit costs are the amounts paid by the plan, after employee copays are applied

# Medical Specialty Pharmacy

#### Place of Service

- Visits for medical specialty medications in 2023:
  - The provider's office was the most common site of care for medical specialty medications, accounting for nearly 64% of all visits and only 34.3% of the allowed amount
  - While outpatient hospital only accounted for 26% of the visits, it was 51.7% of the allowed amount
  - Based on the mix of medications administered to the patients, the most cost-efficient setting was in the provider's office

### Medical Specialty Pharmacy

### Facility vs Provider

- In 2023, allowed amount per service increased in the outpatient facility setting by 17.3%;
   conversely, allowed amount per service administered by a provider in an office increased by only 7.2%
- Allowed per service in the provider's office was 35.4% less than in an outpatient facility in 2023
- Administration of medical specialty medications in the provider's office increased from 2022 to 2023, while patients seeking care in the outpatient facility setting decreased

# High-tech imaging

- Visits for high-tech imaging by site of service from January 2021 December 2023:
  - Average paid per visit for high-tech imaging increased 9.1% from 2021 to 2022 in the outpatient hospital setting, but decreased by 6.3% from 2022 to 2023
  - High-tech imaging in the freestanding facility setting was 78.5% less than in an outpatient hospital setting during 2023
  - Potential cost avoidance if all high-tech imaging was performed at a freestanding facility location would be \$12.6M

# Basic imaging

- Visits for basic imaging by site of service from January 2021 December 2023:
  - Average paid per visit consistently increased in the hospital outpatient setting
  - At freestanding locations, there was an increase in average paid per visit in 2022; however, during 2023 we saw this average return to the same level as 2021
  - Visits in the freestanding facility location increased at a greater rate than in the outpatient hospital setting
  - Potential cost avoidance if all basic imaging was performed in freestanding facility would be approximately \$3.8M

### Labs

- In 2023, average cost per visit in a preferred lab was 65.3% less than in hospital outpatient lab, and hospital outpatient lab visits on average increased 3.5% and 1.0% in 2022 and 2023, respectively
- In the preferred lab setting, there was an increase in visits in 2022 of 3.0%, but this decreased by 1.7% during 2023
- Average paid per lab decreased in all settings from 2021 to 2022 and remained stable in 2023
- If all labs were performed at a preferred location, there would be potential savings of \$4.3M
