## Financial Updates

### Q. What is the status of the Group Health Insurance Plan (GHIP) Health Fund?

A. As of September 2025, the GHIP Health Fund had an ending cash balance of approximately \$84.5 million after accounting for August Fund experience. The SEBC projects that the Health Fund will end Fiscal Year 2026 with an ending cash balance of \$131.1 million and will continue to build toward an adequate surplus and cash minimum reserve of 4% to cover future health care costs.

## **Benefit Updates**

### Q. What changes is SEBC considering to the incentive structure of the Lantern Surgeons of Excellence Program?

A. At the September 25, 2025 SEBC meeting, the SEBC began discussing proposed revisions to the current incentive structure of the <u>Lantern Surgeons of Excellence</u> benefit for non-Medicare health plan members. The Lantern benefit is a comprehensive surgical program that provides a personalized concierge experience from dedicated Care Advocates and access to excellent health care through a network of credentialed Surgeons of Excellence for planned, non-emergent procedures.

The SEBC is considering the following changes to the incentive structure:

- Decreasing the member incentive for Spine and Joint procedures from \$4,000 to \$3,000.
- Decreasing the member incentive for Gynecological procedures from \$2,000 to \$1,000.
- Increasing the member incentive for Cardiac procedures from \$2,000 to \$3,000.

#### Q. What is the status of the Calendar Year 2025 Request for Proposals (RFPs)?

A. The SEBC is managing five RFPs at various stages throughout calendar year 2025. The chart below details each RFPs' status, upcoming actions involving SBO, SEBC, or Proposal Review Committees (PRCs), as well as the anticipated contract effective dates.
