

SEBC and SEBC Subcommittee Meetings (September 2025 Updates) Get the Facts on What's Happening

As the "administrative arm" of the State Employee Benefits Committee (SEBC), the Statewide Benefits Office (SBO), Department of Human Resources (DHR) is providing the following frequently asked questions document as a resource to employees and retirees, which includes facts on what's being discussed related to the Group Health Insurance Plan (GHIP) at the SEBC and SEBC Subcommittee meetings and actions taken by the SEBC.

Frequently Asked Questions:

Financial Updates

Q. What is the status of the Group Health Insurance Plan (GHIP) Health Fund?

A. As of August 2025, the GHIP Health Fund had an ending cash balance of \$61.7 million. The SEBC projects that the Health Fund will end Fiscal Year 2026 with an ending cash balance of \$77.5 million and will continue to build toward an adequate surplus and cash minimum reserve of 4% to cover future health care costs.

Q. What decision did the SEBC make regarding the Fiscal Year 2026 Budget for the Group Health Insurance Plan (GHIP)?

A. At the September 2, 2025 SEBC meeting, the SEBC voted to approve the Fiscal Year (FY) 2026 budget for the Group Health Insurance Plan (GHIP). The FY2026 budget establishes anticipated operating revenues, expenses, net monthly income, reserves, and surpluses needed to manage the GHIP. The total operating expenses for FY2026 are projected to be just above \$1.54 billion, with total revenues expected to be just above \$1.58 billion.

Benefit Updates

Q. When will the 2025 Special Medicfill Open Enrollment take place?

A. The State of Delaware's 2025 Special Medicfill Open Enrollment for the Highmark Delaware Special Medicfill Medicare Supplement Plan (with or without prescription) will be October 20 – 31, 2025 for benefits effective January 1, 2026. Information on this Open Enrollment will be included in the Office of Pensions October 2025 - Retiree Healthcare Newsletter being mailed on September 29, 2025 and Open Enrollment packets from the Office of the Pensions will be mailed on October 6, 2025. Plan rates, frequently asked questions, and additional resources will be posted to both the SBO and Office of the Pensions websites and the Highmark Delaware Special Medicfill Medicare Supplement Plan booklet will be posted prior to Open Enrollment.

Request for Proposals (RFP) Updates

Q. What is the status of the Calendar Year 2025 Request for Proposals (RFPs)?

A. The SEBC is managing five RFPs at various stages throughout calendar year 2025. The chart below details each RFPs' status, upcoming actions involving SBO, SEBC, or Proposal Review Committees (PRCs), as well as the anticipated contract effective dates.
