### 2009 Recipient – Tax Amnesty Program Team

#### Delaware Department of Finance/Division of Revenue and the General Revenue Corporation

The **Tax Amnesty Program Team** was chosen for the successful implementation of a tax amnesty program that created new jobs for Delaware residents, reduced 75% of personal income liabilities, satisfied 25% of business tax liabilities and netted over \$22 million in revenue for the State of Delaware, well exceeding the original \$10 million estimate.

### The Delaware ERP e-Pay Project Team -

As a result of the Governor Markell's Performance Review Initiative, this multi-agency team developed a way to eliminate paper pay advices and reduce costs associated with printing, paper envelopes, delivery, postage, and sorting. This team consisting of members from the Office of Management and Budge/Payroll Human Resource Statewide Technology (PHRST), the Department of Technology and Information (DTI), and the Department of Finance worked together to implement the new payroll system that enables state employees to view their payroll information online 24 hours a day, seven days a week.

The Delaware Teen Driver Task Force - The Delaware Teen Driver Task Force, led by the Delaware Department of Transportation, built a bridge of cooperation to accomplish three initiatives under the motto of "Delaware Does More for Teen Driving". The success of the team includes creating website dedicated to teen drivers which received 202.000 hits in the first three months, creating a teen driver alert program with dissemination of 13,000 reflective "Novice Driver" magnets and stickers, and developing a training program called the Graduated Drivers Licensing Parent Orientation Program (GDL POP), with five programs being conducted statewide in a four months. The Task Force includes representatives from the Department of Vehicles, Transportation/Division of Motor

Department of Safety and Homeland Security/Office of Highway Safety, Delaware State Police, Department of Education, AAA Mid-Atlantic, and the Delmarva Broadcasting's SmartDrive. **The Elections e-Signature Project Team** - This multiagency team, led by the Commissioner of Elections, consisting of representatives the Department of Transportation(DelDOT)/Division of Motor Vehicles (DMV), and the Department of Technology and Information (DTI) worked together for a common goal of improving the accuracy of election information and saving resources through the creation of a new statewide, streamlined method of registering and maintaining voter registration for the citizens of Delaware. The new system will result in annual savings of approximately \$487,900 in paper, postage, equipment and transportation costs for the Department of Elections and a savings of \$50,000, for the Division of Motor



Vehicles (DMV). The improvements have provided a customer friendly process with a reduction in customer response time for the elections process and one-stop shopping for DMV customers. This project supports the State's Green Initiative and Delaware is only one of eight states with such a program.
